Report Objective

To consider the nomination of Cr Rebbeck for the position of Chair of Murray Darling Association Region 6 (MDA-R6).

Executive Summary

The Annual General Meeting (AGM) of MDA-R6 is scheduled for 15 February 2019. At the AGM, the membership of MDA-R6 will elect a Region Chair and a Region Committee. The Region Committee currently consists of the Region Chair, one other member of MDA-R6 and the three CEOs (or their delegates) of Alexandrina Council, Coorong District Council and Rural City of Murray Bridge.

Cr Rebbeck has submitted a nomination for the position of MDA-R6 Chair and/or Region Committee member. The MDA requires that any nomination from a serving councillor be accompanied by a resolution of Council endorsing the nomination.

Recommendation

Option 1

That Council endorse the nomination of Cr Melissa Rebbeck for the position of Chair of Murray Darling Association Region 6.

Or

Option 2

That Council does not endorse the nomination of Cr Melissa Rebbeck for the position of Chair of Murray Darling Association Region 6.

Context

The Murray Darling Association (MDA) is a membership based peakrepresentative body representing local government and communities across the Murray-Darling Basin.

The vision of the MDA is a healthy Murray-Darling Basin which supports thriving communities, economic development and sustainable productivity. The purpose of the MDA is to provide effective representation of local government and communities at a state and federal level in the management of Basin resources by providing information, facilitating debate and seeking to influence government policy.

Local governments form the core membership base of the MDA but individuals, businesses, not-for-profit and community service organisations can also become associate members.

The MDA comprises 12 regions across Queensland, New South Wales, Australian Capital Territory, Victoria and South Australia and the Chair of each region becomes a Board Member of the MDA.

Alexandrina Council is a member of MDA Region 6, along with Coorong District Council, Rural City of Murray Bridge, and Tatiara District Council.

Alexandrina Council is entitled to appoint three voting delegates to MDA-R6 and at the Council meeting held on 17 December 2018, Council appointed CEO Glenn Rappensberg, Cr Michael Scott and Cr Melissa Rebbeck.

General Analysis

In the previous term of Council, Alexandrina's representatives on MDA-R6 were Cr Barry Featherston, Cr Michael Scott and Cr Frank Tuckwell. Cr Featherston was also Chair of MDA-R6 and the National Vice President of the MDA.

Cr Featherston was not returned at the 2018 Local Government elections and the position of MDA-R6 Chair has thus been vacant since November 2018.

The next meeting of MDA-R6 is the Annual General Meeting (AGM) scheduled for 15 February 2019.

At the AGM, the membership of MDA-R6 will elect a Region Chair and a Region Committee. The Region Committee currently consists of the Region Chair, one other member of MDA-R6 and the three CEOs (or their delegates) of Alexandrina Council, Coorong District Council and Rural City of Murray Bridge.

Cr Rebbeck has submitted a nomination for the position of MDA-R6 Chair and/or Region Committee member. The MDA requires that any nomination from a serving councillor be accompanied by a resolution of Council endorsing the nomination. Rural City of Murray Bridge has endorsed Mayor Brenton Lewis for the position of Chair whilst Coorong District Council has endorsed Cr Vern Leng.

Comparative Analysis

There are over 160 councils within the Murray Darling Basin and approximately 100 of these are current members of the Murray Darling Association.

Financial and Economic Implications

Elected Member travel expenses associated with attendance at MDA-R6 meetings are covered by the Elected Members' Allowances, Benefits, Support & Facilities Policy.

Risk Management

In accordance with the Alexandrina Risk Management Policy and Matrix, the risk of adopting the recommendation in this report is considered low.

- 2. That pursuant to section 91(9)(c) of the Act the Council delegates to the Chief Executive Officer the power to revoke the order made in paragraph 1 of this resolution at any time.
